RIGHTS GRANTED

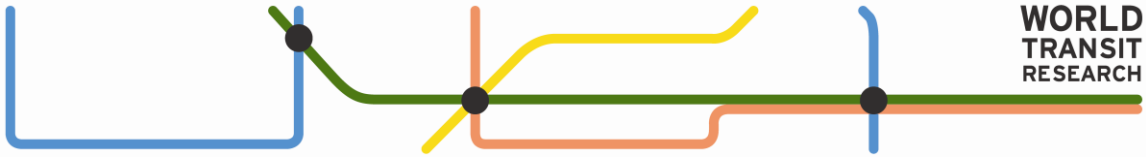
